## 2023 Stationing and Circuit Invitation Committee

PROPOSAL: The Circuit meeting appoints that the invitation committee for the next twelve months will be made up of: (1) All CLT including the Circuit Treasurer (2) Kathy Bamber, Shirley Cormack \& Cathy Hartley (Jonathan Whitfield as a reserve for Cathy) and have delegated powers to offer initial invitations. Agreed.

Local Preachers' \& Worship Leaders' Meeting: The meeting will take place on Thursday $\mathbf{2 2}^{\text {nd }}$ September.
The Church resource directory has had a response from seven churches - Peter will send a second request to the churches that have not replied.
The Preaching Plan Held Cluster Zoom services during July \& August hosted from Lancaster \& Trinity Goosnargh.
Action: Church Stewards to email Rev Keith with feedback, how these Zoom services were received - Pros \& Cons.

Christmas Day \& New Year's Day Services- advise if services are being held.
Winter Plan - consider clustering to save energy costs.

The Advanced Modules will take place on $17^{\text {th }}$ November \& $\mathbf{2 8}^{\text {th }}$ November and a reminder that all Local Preachers and Worship Leaders must complete this training.

Finance \& Budget 2022-23 - Sandra Cooper (see separate Document) Grant Application for new IT via the CLT to be extended for 12 months.
Action: New Bank Account details to be circulated to Treasurers. Actioned 24/09/22

Tewitfield: Synod gave permission to cease worship and sell. Section 333: Resolution agreed. Any two of the following charity trustees of the Charity be authorised to approve, sign, and execute any document to which the charity trustees of the Charity from time to time are a party with the intention that any document executed under this authority will have the same effect as if executed by all of the charity trustees of the Charity:
PROPOSAL: Rev Andrew Champley, Rev Roy Burley \& Rev Steve Charman agreed.

The Circuit Stewards would prefer us to use a different Surveyor for Tewitfield than we have been using for other properties. Rev Keith has contacted the Superintendent of North Cumbria Circuit who has recommended their surveyor. This has approval of TMCP and the District Property Secretary.
PROPOSAL: To seek permission to use someone different agreed.

The district will visit to check if the Lune Valley Hub is a suitable venue to host the Spring Synod.

GDPR \& Data Retention: All new Trustees must complete a new Declaration Form. We have spoken to the Legal Counsel from the Connexion and it has been confirmed that, Trustee Declaration Forms do not have to be completed annually though it is good practice to do so. (The Methodist Church Website currently shows incorrect information (since June 2020) regarding Trustees). GDPR forms to be completed by all Trustees every two years for the Circuit Directory.

## Appendix CLT Report

## CLT Report to Circuit Meeting Thursday 22nd September 2022

Since the last Circuit Meeting in June, the Circuit Stewards received the news which has now been disseminated to the whole Circuit, that our Superintendent, Rev Steve Charman, has been appointed (subject to Conference approval), as Deputy Chair of Shetland with effect from 1st September 2023.

We were already aware that Rev Keith Borwick hopes to "sit down" in August 2023, and so we are faced with the prospect of trying to fill two ministerial positions in the current rounds of stationing.

This is the responsibility of the Circuit Stewards and the Circuit Invitation Committee, and we are bringing a proposal tonight to widen the membership of the Circuit Invitation Committee to include a range of views from different parts of the Circuit.

There is, as we are all aware, a shortage of Presbyters available for stationing, and there are more stations to fill than Presbyters available. To this end, the Circuit Stewards have prepared a "Strategy Statement" which has already been outlined by Peter.

We have been in constant communication with Rev Phil Gough, District Chair, and he has advised that it is unlikely that we shall be able to appoint two Presbyters to this Circuit for 1st September 2023. The appointment of a Superintendent will probably be designated a "Critical Appointment" and there is a good chance that this station will be filled by an experienced Presbyter.

We have, therefore, been in contact with the Warden of the Diaconal Order, who came to visit us on 5th September, looking at the Garstang Project in particular, to assess the suitability of the station for a Deacon. There are obvious differences between a Diaconal appointment and a Presbyteral appointment (there are some booklets at the back of the Church regarding Deacons and their work, and I urge you to take one and read it). We felt, however, that with the support of some of our supernumerary ministers, it might be possible to fill this station with a Deacon.

The process for appointing Deacons is different from that for Presbyters, as they are stationed directly by the Warden. We have therefore, submitted a Diaconal profile to the Warden for her to consider and give us some more feedback about the suitability of the position for a Deacon.

In the meantime, because deadlines loom, we have submitted two Presbyteral profiles to Rev Phil Gough, who has approved them, but feels that the matching committee is unlikely to be able to match a Presbyter to the second profile.

The matching process for Deacons will take place in January 2023, and we will have to wait for our profile to be considered then.

In addition, we have been looking at our funds and the possibility of monies being added to them as we sell buildings. We would like to be able to bring a proposal to the next Circuit Meeting to spend some of this money on Ministry and Mission, which could well involve extra Lay personnel to help with the new projects. (We would have brought a proposal tonight, but the sales are still not completed, and we did not want to be presumptuous.)

We expect to hear about the Superintendent station in November, when the prospective "match" will meet with the Circuit Invitation Committee and some members of the Churches for whom they will be responsible. The Circuit Invitation Committee will then meet to decide whether we will issue
an invitation to this person, and they, in turn, will decide whether they feel that it is the Lord's will for them to come to this Circuit.

We will, then be turning our attention to the station at Garstang and filling it according to our understanding of the Lord's will for this Circuit and will keep you updated at the November Circuit Meeting.

We have, of course, being doing all of this while our Superintendent is on sabbatical, and I should like to thank Rev Keith for all his work and support as Acting Superintendent. He has been an untold blessing to me and the other Circuit Stewards in his gentle, but firm way of dealing with issues, and his energy in helping us to put forward the profile for Garstang has been inspiring. We owe him a great debt of gratitude which we can never repay, and we all want the Garstang project to go forward to recompense his vision and hard work in some small way. We also thank him for all the other duties that he has performed as Acting Superintendent over these fifteen weeks, and the patient way that he has dealt with the many property issues and everyday pastoral issues alongside his own duties as Minister.

In summary, then:

- We have submitted two Presbyteral Profiles, one for Superintendent, one possibly for Garstang
- We are discussing with The Warden of the Diaconal Order the possibility of a Deacon for the Garstang Project, and possibly other Diaconal work.
- We await a response from the Stationing Committee, expected early November.
- We are considering the possibility of extra Lay Personnel as we will have some funds released from the sale of buildings and may be able to apply to the new Connexional Fund "New places for New People".

We seek your prayers as we continue to explore these avenues and look forward to bringing you some further news at the November Circuit Meeting.
